## **Capital Connection Apostille Instructions.**

Please send the original document you would like to have apostilled along with the completed Capital Connection Florida Apostille Cover Letter, one check or money order made payable to: Capital Connection, Inc and one check or money order made payable to: The Secretary of State. (Money orders are also accepted)

We suggest using Fedex or UPS to overnight your documents to us. This way you have a tracking number and your documents are less likely to be lost in shipping.

When we receive your documents we will begin the process of apostilling your documents. The average turn around time is 24hours.

Typical Example of How Long The Process Takes With Overnight Shipping.

If we receive your documents Tuesday Morning by 11am, then the apostille will be completed by Tuesday Afternoon or Wednesday Morning. (24 Hours)

We will then overnight the apostilled documents back to you.

You would receive your apostilled documents on Wednesday or Thursday delivered by UPS.

Almost every Apostille we process is completed in 24 hours from the time we receive it. We can never guarantee the 24 hour turn around time since the Secretary of State may experience unexpected problems or delays. The 24 hour turn around time is based on a business week Monday - Friday. State holidays may also create a delay in processing requests.
